## Guide to African American Sources

The H. Furlong Baldwin Library at the Maryland Center for History and Culture possesses a variety of resources for those researching African Americans or their history, including books, photographs, oral histories, manuscripts, and various records and directories. The collection is strongest in materials from the 19<sup>th</sup> and 20<sup>th</sup> centuries. The Library’s significant holding of materials relating to the efforts to colonize freed blacks in Liberia and its transcripts of oral histories are particularly interesting.

A number of influential African Americans were born in Maryland or called it home. Harriet Tubman was born in Dorchester County, and Frederick Douglass’s narrative of his escape from slavery on a Maryland plantation is well known. Books on these and other individuals are included in the Library’s collection and can be found by searching for the individual’s name in the Library’s online catalog. The Eubie Blake Papers can be examined in the Main Reading Room, and many items of correspondence and other miscellany from this collection are available online. General histories of African American life or more specific accounts can also be found. A good place to start is by browsing through the subjects on the online catalog that begin “Afro-American” or “Afro-Americans.” To aid in your research we have also listed below some of the main sources relating to African Americans. **Please keep in mind that this list is not comprehensive.**

## I. SLAVERY

Many photographs of African Americans are available online. Numerous photograph collections include some images of African Americans.
